## Overview

If you are a veteran who initially enlisted on or after 1 July 2004 you can apply for additional benefits relating to existing medical conditions for which DVA has accepted liability.

The Request additional benefits screen is not available to all MyAccount clients.



Due to legislative limitations, the Request additional benefits screen is only available to clients with an existing claim arising from service on or after 1 July 2004 made and assessed in accordance with the Military Rehabilitation and Compensation Act 2004 (MRCA) legislation and who have no other types of claim.
